BECOME A FRIEND OF EQUAMORE THROUGH THE BUY A BALE PROGRAM OR AS RESCUE TEAM MEMBER DEDICATED TO THE CARE OF ONE OF THE EQUAMORE HORSES: THE BUY A BALE PROGRAM HAS A GOAL ESTABLISHING 1,000 FRIENDS THAT PROVIDE A MINIMUM MONTHLY DONATION OF \$12/MONTH. THE PROGRAM HELPS HORSES ONE MONTH AT A TIME. THE \$12 DONATION FEEDS ONE HORSE FOR A WEEK. RESCUE TEAM MEMBERS SELECT ONE OF THE 48 EQUAMORE SANCTUARY HORSES TO SUPPORT. EACH TEAM HAS A CAPTAIN WHO ORGANIZES THE FUNDRAISING FOR THEIR TEAM'S HORSE. IN ADDITION TEAM MEMBERS RECEIVE UPDATES ON THEIR HORSES ACTIVITIES AND ONGOING CARE. TEAM MEMBERS THAT LIVE NEAR THE SANCTUARY OFTEN VISIT THEIR TEAM'S HORSE. IN 2016 THERE WERE 31 ACTIVE RESCUE TEAMS PROVIDING SUPPORT TO THE EQUAMORE HORSES.

OREGON HAY BANK: THE HAY BANK PROVIDES TEMPORARY FINANCIAL SUPPORT TO RESPONSIBLE HORSE OWNERS THAT ARE HAVING FINANCIAL DIFFICULTIES AND NEED HELP TO KEEP THEIR HORSES AT HOME WITH THEIR FAMILIES. THE CURRENT ECONOMIC TIMES HAVE CREATED AN ADDITIONAL DEMAND FOR THIS PROGRAM. STATISTICS SHOW THAT THE OUTREACH PROGRAM HAS A 95% SUCCESS RATE OF KEEPING HORSES IN THEIR CURRENT HOMES. AN APPLICATION IS FILED, REVIEWED, AND MUST MEET SPECIFIC CRITERIA BEFORE FUNDS ARE AWARDED. THE HAY BANK ALSO RESPONDS TO REQUESTS FROM LAW ENFORCEMENT AND OTHER NON-PROFITS TO ASSIST WITH THE NEED FOR HAY IN SEIZURES AND SURRENDERS.
